TWO-WEEK FESTIVAL

THE Belfast Linen Quarter (LQ) BID and Belfast City Council have come together to create RE[act] – a two-week festival kicking off today in line with COP26 and dedicated to inspiring Belfast's response to the global climate crisis.

The first festival of its kind, it will tap into various themes such as food, fashion, finance, transport, waste and more with international speakers, local experts and more contributing to the programme. RE[act]'s programme has been designed specifically so that all walks of life and all industries can attend.

Carol Lemmens of ARUP's Amsterdam team will lead an opening event discussing how Belfast can develop a more circular economy through how individuals live their lives, how organisations conduct their business and how city stakeholders should develop.

Sarah Longlands, chief executive of Centre for Local Economic Strategies (CLES), will chair a workshop style session on Community Wealth Building which will offer participants the chance to discover what inequalities across the city may mean both for Belfast's societal wellbeing and long-term sustainability.

A two-day contemporary art project, open to all members of public, will take place at Queen's University, offering the chance to contribute to a striking piece of art made from discarded items.
